Purpose & Effect of the Proposed By-law	To rezone a water lot from the Waterfront Open Space "(WOS)" Development Permit Area to a Waterfront Open Space with an Exception "(WOS-EXXX)" Development Permit Area to facilitate the reconfiguration, reorientation and reconstruction of previously existing legal non-conforming, non-complying docks along the shoreline of Raven Lake, with a maximum dock length from the shoreline of 53.6 metres (176 ft.) to accommodate a maximum of 96 boat slips (being 4 docks each containing 24 boat slips).
	Docks previously existed along the shoreline, which have since been removed as ordered by MNDMNRF. As a number of the properties along Raven Lake are water access only, the Raven Lake Dock Association applied to the MNDMNRF for a Land Use Permit, whereby the permit was issued by MNDMNRF for docking along a portion of the shoreline of Raven Lake. The proposed docking is located within the permitted Land Use Permit boundaries.

To receive notice of future meetings	If you wish to be notified of the decision of the Township on the proposed zoning by law amendment, you must make a written request to the planning contact above.

If a person or public body would otherwise have an ability to appeal the decision of the Township to the Local Planning Appeal Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Lake of Bays before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Township before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.


